 - Sent a reminder e-mail after the May board meeting, haven't received a reply yet.

Technical Report:

- Added sponsor spots to the website so they can be played on demand
- Updated the Kroger Rewards page
- Added Banner for Kroger Rewards annual renewal
- Added London First Church of God page to Program Guide
 - o Not Published pending time slot and when they start airing.
- Added menu option under High School Sports for the GOTW Schedule
 - This shows the entire season GOTW Schedule on one page
- Re-activated MixIr
- Set up debit card on Verizon Jetpack account.
 - o If we use over 6GB per month, it's cheaper to use refill cards, but the option is available to purchase data online if needed.
 - Their system is set up on a monthly schedule.
 - I initially bought a \$30 card for 500MB of data on 7/17
 - On 8/2 I bought a \$50 card for 8GB of data.
 - I was able to add the \$50 card as a payment method, but their system was scheduled to charge \$30 on 8/17 for 500MB of data.

- I upgraded to the 8GB plan and they charged \$20 for the remainder of the monthly cycle.
- On 8/17 the plan will expire and \$50 will be charged for the next monthly cycle.
- I also learned that plans can only be changed once per cycle.
- o First Meet the Team broadcast was just over 25MB of data.
- Second Meet the team (just over an hour) 28MB of data
- Rick and I did a test with the complete remote setup using MixIr and the Jetpack.
 - There was some line noise, but I was able to minimize it by adjusting the setting on the remote mixer board.
 - After we tore down Rick realized he was using the old remote mixer board, so the new board should work fine.
- Purchased:
 - o 2 Whirlwind AES/EBU 1x2 Passive Splitters \$144.00ea
 - 1 SEISMIC AUDIO SAXLX-2-2 Pack of 2' XLR Male to XLR Female Patch Cables -Balanced - 2 Foot Patch Cord - Black and Black \$12.99
 - 1 Devinal 1/8 inch TRS to Dual XLR Female Y-Adapter Cable, 3.5mm Mini Jack Stereo Male to 2 XLR Female Interconnect Breakout Y Patch Cable Cord 10 Feet (3 Meters) \$16.99
 - Total: \$318.98
- Rick and I installed the new hardware and found that the over air quality was good, but not the live stream quality. There was some background buzz, and the volume was too soft.
 - O I was able to use one of the new cords to connect the Production computer to the AUD Out jacks on the back of the studio board and moved the Live Stream output back to the headphone jack on the studio board. In addition, I relocated the headphones from the headphone jack to the booth out jack on the back of the studio board.
 - Now:
 - anything running to the PGM out will be going over the air
 - Anything running to the AUD out will be going to the Production Computer
 - All headphones are connected to the Booth Out and a button on the Studio Board will allow selection of PGM or AUD to go through the Booth Out jack.
 - The Live Stream output is coming from the headphones jack on the Studio Board just as it always had and is not affected by what is going out of the AUD channel.
 - I have retuned the two XLR splitters for a refund of \$288, since they are not used in this configuration.
- Issue with one input on RPU
 - o Does not affect football season. Will address after the season.
- Issue with one channel dropping out on Mixlr broadcast
 - o Didn't have an issue on the London Meet the Team broadcast
- Fair Parking flag has been repaired and returned to the station
