# **Technical Report:**

#### Discussion Items:

- Added Listen Live button to the top sidebar of the home page to make it more visible per Greg's suggestion.
- Added link to Madison County Spotlight under Community News menu item and Local Interests sidebar menu on the home page
- Added 'Post Game with Ron Otto' under High School Sports which lists all of Ron's post game podcasts.
- Added 'Madison County Football Statistics' under High School Sports which lists the county wide statistics that Greg has compiled.
  - Will be updated weekly around mid-week
  - o Promote on radio, game broadcasts, Facebook, Ron Otto's postgame show
- Issue with Jetpack 'Out of Data Allowance'.
  - Went through the password reset process to regain access to the account.
  - For some reason the \$50 8GB plan expired early.
  - Had to purchase another month at \$50 since I was not allowed to change plans when it was expired.
  - New plan is \$40 for 3GB
    - Double data is active on this account so it's actually 6GB
    - I turned on autopay, so this won't happen again
      - This saves an additional \$5 on the plan
    - So, on 9/24 the plan should automatically renew for \$35 and 6GB of data
      - This did occur
    - I plan on turning off autopay at the end of basketball season
      - Should we need this during the off season it would be \$40 to start it up (without autopay, and I can't switch plans when it's expired).
- Need to watch Live Stream Bandwidth
  - o Max per plan is 500GB/month we were at 370GB last month
  - o If we need to upgrade, the next plan is \$36/month for 750GB of data
- Station Calendar
  - o Do we still want this?
    - Decided to table it at this time but may need it in the future
      - I will play around with this in development
- Issue with one input on RPU
  - o Does not affect football season. Will address after the season.
