## **Technical Report:**

#### **Discussion Items**

- The 2024 Football Schedules and GOTW schedule is up on the website.
  - The GOTW Banners will start on Saturday August 3rd
- The JW Player (used for podcasts) licensing fees went way up from around \$90/year to almost \$2,000 per year.
  - I have reverted back to an old version of the player until I can re-write the code to use something else.

- In development, I have replaced the JW player with video.js, which is an opensource player. I have been able to re-write the code using the new player. I am currently working on the Podcast Administration interface to the website to feed the list of podcasts to the new player.
- The website was experiencing performance issues due to lack of disk space. I put in a ticket and they moved the website to a different 'node' to address this issue. The website was offline for a couple of hours Monday morning (around 5am 7am).
  - I checked after it came back online, and the home directory was still 99% full. When I asked, they said that website was 'too large' to migrate. I explained that I had already removed all of the backups, temp files and log files and that the biggest usage of disk space is our podcasts. I was told that the hosting site should not be used for file storage.
    - They did say that they identified an issue with their database server that was causing an impact on the website performance. - The performance did get better after this fix.
    - They recommened using Google Drive, DropBox, etc. these solutions only allow the file to be downloaded, not played live from the site. I am currently working on a solution. Here are some options:
      - Host the files ourselves I am testing this option now using a networked drive. It would require opening the drive up to the internet and there is increased risk of cyber-attacks doing this. There is also the issue of keeping the drive online 24/7. The upside is that a network drive is only around \$200 and there would be no additional charges.
      - Use a 3<sup>rd</sup> party company to hosts our podcasts. PodBean is an example. This would require drastic changes in how we publish our podcasts, and integrate them into the website. There are also fees involved. PodBean for example would start at \$10/month.
      - Leave things the way they are now. May continue to experience slow website performance.
