### **Technical Report:**

Discussion Items:

- Website was down from about 4pm on 3/30 to 8am on 3/31
  - Re-installed Joomla to fix the HTTP 500 error
    - Possibly a corrupted file
- A folder with the E-Mail accounts got deleted somehow on or around April 1st
  - Bluehost has restored the folder from a backup taken on April 1st
    - The restore took 2 days to happen, so e-mail was down from April 1st to April 2nd
    - I sent a test email while it was down, but the e-mail did not go through, and it was not rejected, so the sender has no indication that the e-mail did not go through
- Review of reworked home page of website focusing on locally produced content
  - The team liked the work, but decided Brian's suggestion for version 2 would be better
  - Brian will re-mock the version 2 and present for approval before the next meeting
